ESRD Risk Scores

CMS has pushed out to all Medicare Advantage (MA) organizations and 1876 Cost Plans a beneficiary level file that your actuaries will be using to develop 2024 Part C bids. This memo is to inform you that there may be potential action that is needed for you to accept this new file. Please also note that we posted contract-PBP level risk scores for the payment year models on HPMS. In addition, we are sending to all MA organizations and 1876 Cost Plans that enrolled ESRD beneficiaries in 2022 a second beneficiary-level file with the ESRD risk scores of these enrollees.

Below is the file layout with technical notes.

<u>Technical Notes – </u>

Please note the following:

- 1. The file includes all beneficiaries who were enrolled in your contract for at least one month in 2022, including beneficiaries with Part A only or Part B only.
- 2. The payment year (PY) 2022 Part C risk scores were calculated using two different versions of the CMS-HCC risk adjustment models: (1) the model that was used for 2022 payment and will be used, in part, in 2024 payment (the 2020 CMS-HCC risk adjustment model, first implemented in 2020), and (2) the updated CMS-HCC risk adjustment model that will be implemented for 2024 payment (the 2024 CMS-HCC risk adjustment model as finalized in the 2024 Rate Announcement).

We are providing the following sets of PY 2022 risk scores (2021 dates of service):

- 2020 CMS-HCC risk adjustment model: Risk scores calculated using diagnoses from the Encounter Data System (EDS) and CPT/HCPCs filtered FFS claims, and
- 2024 CMS-HCC risk adjustment model: Risk scores calculated using diagnoses from the EDS and CPT/HCPCS filtered FFS claims.

Part C risk score file layouts are provided at the end of this memo.

- 4. The risk scores are <u>not</u> normalized and do <u>not</u> have an MA coding adjustment factor applied.
 - The 2020 CMS-HCC model has a 2015 denominator and 2024 CMS-HCC model has a 2020 denominator. Your projected 2024 risk score will need to consider the appropriate normalization factor, per the 2024 Bid Pricing Tool Instructions. The PY 2024 normalization factor for the 2020 CMS-HCC risk adjustment model is 1.146 and the PY 2024 normalization factor for the 2024 CMS-HCC model is 1.015.
- 5. The PY 2022 risk scores provided are estimated interim final risk scores.
 - The diagnosis data used for the risk score estimates are from calendar year 2021 dates of service (i.e., the data collection period) based on: 1) plan diagnosis data submitted to EDS through January 31, 2023, and 2) Medicare FFS diagnosis data through January 31, 2023.

- The estimated PY 2022 risk scores account for retroactive adjustments for (1) enrollment and disenrollment through January 2023, (2) long term institutional (LTI) status through February 9, 2023, and (3) Medicaid status updates through January 2023.
- 6. For the estimated interim final PY 2022 **encounter data-based risk scores**, CMS used the January 31, 2023 cutoff for diagnoses from the EDS for the 2020 CMS-HCC model risk scores and the 2024 CMS-HCC model risk scores. Final PY 2022 risk scores will include a longer runout of encounter data and FFS diagnoses.
- 7. We note that, for bidding, organizations will need to adjust the 2022 (base year) CMS-provided encounter data-based risk scores for the runout in diagnoses submitted on encounter data and chart review records beyond the January 31, 2023 cutoff used for these risk scores. In the May 18, 2022 HPMS memo "Deadline for Submitting Risk Adjustment Data for Use in Risk Score Calculation Runs for Payment Years 2021, 2022, 2023, and 2024," CMS provided information about the extension of the encounter data submission deadline for risk adjustment purposes for 2022 (2021 dates of service) until July 31, 2023.disabled, ESRD).
- 8. Organizations should determine which risk scores apply for a month by determining the beneficiary's status (e.g., LTI, community, new enrollee, etc.) for that month, using the "Part C Beneficiary status field" (fields 62-73 in the layout).
- 9. For full risk community beneficiaries, estimated interim final risk scores calculated using the 2024 CMS-HCC model and 2020 CMS-HCC model are based on monthly Medicaid status in the payment year. The data provided in the beneficiary-level file includes the Medicaid statuses that plans can use to select the appropriate risk score for a month for community beneficiaries (fields 38-49 in the layout). Given a beneficiary's aged versus disabled status for 2022 (determined by their age as of February 1, 2022), we provide their three possible community risk scores for the year, reflecting either non-dual, full benefit (FB) dual, or partial benefit (PB) dual status. For each month in the payment year, a community beneficiary will have a risk score selected among the three community statuses (i.e., non-dual, PB dual, and FB dual) for each model.
- 10. Chronic Condition SNPs (C-SNPs) All MA organizations will receive beneficiary-level files that include C-SNP new enrollee risk scores. Organizations that do not operate C-SNPs can disregard the C-SNP new enrollee risk scores.

ESRD Risk Scores

11. CMS is providing estimated interim final ESRD risk scores for all organizations that enrolled ESRD beneficiaries in 2022. Risk scores are being provided for ESRD-SNPs to support bidding for PY 2024. For non ESRD-SNPs, CMS is providing risk scores for informational purposes.

- The ESRD risk score file layout is provided below the Part C risk score file layouts at the end of this memo.
- 12. The PY 2022 ESRD risk scores (2021 dates of service) were calculated using the 2020 ESRD risk adjustment models that were used for PY 2022 payment and the 2023 ESRD risk adjustment models that will be used to calculate risk scores for PY 2024 payment.

We are providing the following sets of PY 2022 risk scores (2021 dates of service):

- 2020 ESRD risk adjustment models: Risk scores calculated using diagnoses from the Encounter Data System (EDS) and CPT/HCPCs filtered FFS claims, and
- 2023 ESRD risk adjustment models: Risk scores calculated using diagnoses from the EDS and CPT/HCPCS filtered FFS claims.
- 13. The relative factors for the 2020 ESRD risk adjustment models are published in the 2020 Rate Announcement, published on April 1, 2019. The relative factors for the 2023 ESRD risk adjustment models are published in the 2023 Rate Announcement, published on April 4, 2022. Rate Announcements can be found here.
- 14. The risk scores are <u>not</u> normalized and do <u>not</u> have an MA coding adjustment factor applied. The 2020 ESRD models have a 2015 denominator and the 2023 ESRD models have a 2019 denominator. Your projected 2024 risk score will need to take into account the appropriate normalization factor, per the *2024 Bid Pricing Tool Instructions*, if applicable. The PY 2024 ESRD normalization factors are as follows:
 - o 2023 ESRD Dialysis models: 1.022
 - o 2023 ESRD Functioning Graft models: 1.028
