**SUBJECT:** Deadline for Submitting Risk Adjustment Data for Use in Risk Score Calculation Runs for Payment Years 2022, 2023, 2024 and 2025

This memo is to notify Medicare Advantage Organizations, PACE Organizations, Medicare-Medicaid Plans, Section 1833 Cost Contractors and Section 1876 Cost Contractors, and any demonstration plans of upcoming deadlines to submit risk adjustment data for use in calculating risk scores for Payment Years (PY) 2022, 2023, 2024, and 2025. All risk adjustment data (Risk Adjustment Processing System (RAPS) Data and Encounter Data System (EDS) Data) that will be included in the listed risk score runs need to be submitted by 8 pm ET of the “Deadline for Submission of Risk Adjustment Data.”

We encourage organizations to submit their data throughout the data collection period and well in advance of the risk adjustment data submission deadlines to ensure ample time to resolve any data submission issues encountered, such as validation errors or data rejections by the relevant deadline (initial, mid-year, or final).

**No data submitted after 8 PM on the risk adjustment data submission deadline date will be reflected in a model run.** Risk adjustment data submitted after the deadline for an initial run will be included in the mid-year run. Risk adjustment data submitted after the deadline for a mid-year run will be included in the final reconciliation run.

It is important to note that while data must be updated and corrected by organizations before and after the final risk adjustment data submission deadline, CMS will not make additional payments for diagnoses received after the final risk adjustment deadline (42 CFR 422.310(g)).

The following table lists all initial, mid-year, and final risk score runs through the PY 2024 final risk adjustment data submission deadline, with relevant dates of service, and risk adjustment data submission deadlines in the order of future deadlines.

2024 Mid-Year	01/01/2023 – 12/31/2023	Friday, 03/01/2024	TBD
2025 Initial	07/01/2023 – 06/30/2024	Friday, 09/06/2024	January 2025
2024 Final Run	01/01/2023 – 12/31/2023	Friday, 01/31/2025	TBD
